
detectives are investigating a two-vehicle crash that killed a woman and injured several others in Brookhaven on July 7.

Police say a woman driving a van

Police say a woman driving a van carrying eight passengers was traveling westbound on Montauk Highway near Smith Road, when a truck traveling eastbound swerved into her lane and struck her. The hit caused the van to flip over at about 4:55 p.m.

Sandra Leon, 46, of Hempstead, a passenger in the van, was pronounced dead at the scene by a physician assistant from the Office of the Suffolk County Medical Examiner. The driver of the truck, Gerard Demelfi, 28, of Shirley, and the driver of the van, Nieves Rivera, 37, of Patchogue, along with the other surviving passengers in the van, were taken to Brookhaven Memorial Hospital Medical Center in East Patchogue and Stony Brook University Hospital with varying degrees of injuries. Police say a young boy was critically injured and all the other injuries were nonlife-threatening.

The vehicles were impounded for a safety check. The investigation is continuing.

# New charity that assists orphans fundraiser

Christopher P. McGuire, Esq. and James T. Bopp, MD, have announced their formation of HALO (Health and Learning for Orphans) Missions Inc., a nonprofit charity created to provide medical care and educational assistance to orphans in developing countries. McGuire is a local attorney and former Patchogue Village Justice. Bopp is an emergency room and internal medicine physician. He is the former director of Brookhaven Hospital's emergency room and is currently a partner and treating physician at Stat Health in Sayville.

There are more than 132 million orphans living in the world's developing countries and more than 13 million orphans in Sub-Saharan Africa alone. Many of these children live without adult supervision, are in need of medical attention and cannot attend school because they cannot afford the necessary uniforms and supplies. HALO Missions will work with Teen Missions International this upcoming September to provide a mission to Ndola, Zambia. Together they anticipate providing enhanced medical care for at least 500 orphans and will make a donation for the children to attend school.

Others traveling on the mission will include Patchogue Deacon Marty McIndoe of St. Francis de Sales R.C. Church and Brother James Maloney, a Franciscan friar who previously worked at Brookhaven Memorial Hospital. HALO Missions is having a fundraiser on Tuesday, July 28 from 6-8 p.m. at the Law Offices of McGiff & Halverson LLP, at 96 South Ocean Avenue, Patchogue. The suggested donation is \$100. The mission is run by volunteers and all expenses are paid by mission founders. One hundred percent of donations go to medical and educational supplies for the children.
